Need help deciding on the right deduction amount for you?

As a salary deduction sponsor you can donate directly from your pay pre-tax. As donations are automated through your payroll system you get an immediate tax deduction saving the hassle of keeping receipts for your tax return.

- ☆ For example if you give \$10 per pay and your Gross Salary is between \$30,001 and \$75,000 and your marginal tax rate is 31.5% then it actually only costs you \$6.86.
- ☆ For example if you give \$10 per pay and your Gross Salary is between \$75,000 and \$150,000 and your marginal tax rate is 41.5% then it actually only costs you \$5.86.
- ☆ For example if you give \$10 per pay and your Gross Salary is over \$150,000 and your marginal tax rate is 46.5% then it actually only costs you \$5.36.

Remember... Assistance Dogs Australia receives the full \$5 that you donate even though it doesn't cost that much to your hip pocket—it's a great way to give!
